17775. ELECTION OF MAYOR: To elect a Town Mayor for the Council Year May 2015 to May 2016

Cllr S. Hearn, as Mayor for the Council year May 2014-2015, expressed his thanks to all members of the Council for their support during his term of office. He also thanked those councillors who retired from the Council for their years of service – Mrs Denise Rance, Mr Barry Batchelor, Mr Harvey Alison and Mr John Allan.

Cllr Hearn said that his year in office had been a year of remembrance – the $100^{\rm th}$ anniversary of the commencement of World War, the centenary of the awarding of the Victoria Cross to Private Edward Barber and the $70^{\rm th}$ anniversary of VE Day.

The most significant matter dealt with by the Council was the LA5 Development Proposals between the Icknield Way and Aylesbury Road.

He was pleased to report that wherever he had been in the town on his mayoral duties that there was always evidence of the goodwill amongst Tring residents.

The outgoing Mayor then called for nominations for Town Mayor for 2015/16. It was **PROPOSED** by Cllr Mrs P. Hearn and **SECONDED** by Cllr M. Hicks that Cllr S. Hearn be elected Town Mayor for the ensuing year. There being no further nominations, it was unanimously **RESOLVED**: That Councillor S. Hearn be elected Town Mayor to hold office until his successor became entitled to act as Town Mayor at the next Annual Meeting of the Council.

Cllr S. Hearn gave his consent to signing the Declaration of Acceptance of Office and put on the Mayoral Chain of Office. He took the Chair and

welcomed Members – new and returning – and said that he was looking forward to working with them as a community council for the people of Tring and the promotion of Tring.

Cllr S. Hearn announced that, as last year, he was not nominating a specific charity but would be continuing to support a range of local charities.

The Mayor drew Members attention to the notices of sales by auction of various small plots of land in and around Grove Park. He could confirm that these parcels of land were considered to be highway maintainable at public expense. If a road / land has been adopted as highway maintainable at public expense it stays as highway for ever.

Highway land could be within the registered ownership of a third party, but the ownership relates to the subsoil only and the surface will still have highway rights. The owner of the land would not be able to fence the land off the highway or build anything on it. He thanked Cllr N. Hollinghurst for his work on this matter in his role as the Town's County Councillor.

- 1) Overdevelopment of the site -2 or 3 bedroom dwellings would be more appropriate
- 2) Road safety turning into Longfield Road & Aylesbury Road is dangerous because restricted vision of traffic entering Longfield Road from Aylesbury Road and for cars turning left onto Longfield Road and left again onto Aylesbury Road takes them onto the opposite carriage way.
- 3) The site is relatively large and is of ecological value. Any development should protect this aspect of the site. The application gives insufficient details of the measures taken to mitigate any impact of the development

Construction of two semi detached houses, land to the rear of 17 Station Road, Tring HP23 5NG for Mr S Booth

The Council recommended **refusal** of this application. The Council felt that this application failed to address any of the points raised in a previous application that was rejected by Dacorum Borough Council. The Town Council's objections remain:

(a) The development is out-of-keeping with the surroundings. The scale, particularly the height, would be out-of-proportion and over-bearing with reference to the houses behind

(b) It is inappropriate to have an access point for such a development crossing a busy pavement and cycleway. These are heavily used by school pupils. The access point is also close to a bus stop. As a minimum the entrance splay needs to be increased (this is property outside the proposed development)

(c) There is concern that the ownership of this land should have been declared when application 4/00024/14/FUL was made. The drawings submitted with application 4/00365/15/FUL refer to the proposed dwellings as plots 5 & 6. Plots 1-4 are those in application 4/00024/14/FUL.
