18730. ELECTION OF MAYOR

Before calling for nominations, Cllr M. Hicks, as Mayor of the Council May 2016 to May 2017, said how much he had enjoyed his year meeting so many different people and attending such diverse events. The highlight of the year was a spitfire flypast at RAF Halton. He was also very pleased to have been able to officially open Dacorum Borough Council's new houses in Queen Street.

He concluded by thanking all the members of the Council for their support during the year and thanked the staff for their hard work.

Cllr Mrs P. Hearn congratulated Cllr Hicks on his year of office and the way in which he managed several lively meetings.

Cllr Hollinghurst added his appreciation, thanking Cllr Hicks as a first class mayor.

It was **PROPOSED** by Cllr Mrs Conway and **SECONDED** by Cllr M. Hicks that Cllr G. Wilkins be elected Town Mayor for the ensuing year. There being no further nominations, it was unanimously **RESOLVED**: That Councillor G. Wilkins be elected Town Mayor to hold office until his successor became entitled to act as Town Mayor at the next Annual Meeting of the Council.

Cllr G. Wilkins gave his consent by signing the Declaration of Acceptance of Office and put on the Mayoral Chain of Office. He took the Chair and said that he was proud and privileged to accept the position. His aim for the year was to do as much as he could for all the residents of the town, young and old. His nominated charity would be Macmillan Nurses and he was aiming to hold two fund raising events during the year.

18738. <u>APPOINTMENT AND NOMINATION OF REPRESENTATIVES ON OUTSIDE BODIES</u>

A proposed list of representation was circulated prior to the meeting. Removal from the list of organisations with Council representation of the Campaign to Protect Rural England, the Trusteeship of Old Church House and Pitstone Quarry Liaison Group was agreed. Cllr Hollinghurst asked that his representation on the Arla Liaison Group continue as there were still matters relevant to Tring arising e.g. the anaerobic digester. This was agreed.

The Clerk briefed Members on the work of the Dementia-friendly Tring group. Cllr Hicks added his experience as the Chairman of the group. It was agreed that the Mayor remain as the Council's representative until volunteers could be found to take over the role of chairman and secretary.

The Clerk and Cllr Mrs Hearn will be meeting the Practice Manager at the Rothschild House Surgery to discuss the best way to liaise with the surgery. Once agreed Cllr Hicks would be the Council's representative.

The Clerk explained that a draft timetable was prepared on the usual basis with minor changes to accommodate bank holidays. The Clerk reported the following correspondence:

- From the Royal British Legion concerning preparations for a service of commemoration of the 100th Anniversary of the Battle of Passchedaele on the 30th July the eve of the battle
- This acts as a reminder that next year is the 100th Anniversary of the end of WWI. The Clerk and the Royal British Legion are liaising as details of National Events are released under the title "Battle's Over A Nation's Tribute"
- The Chiltern Countryside Group (CCG) alerted the Council on Friday of a consultation by the Department of Transport on policy for design & use of UK airspace, which could have important impacts on airspace above the Chilterns and the AONB. The deadline for the consultation is Thursday 25th May. The Clerk has asked Sue Yeomans, who is the Council's representative on such matters, for a summary of their response. It was agreed due to the deadline that the Clerk and Mayor review the CCG response with the intention that the Town Council endorse the CCG's submission
- Herts Valley Clinical Commission Group have extended the Herts Urgent Care contract to provide primary care services at the New Surgery, Tring until the end of September 2017 with the expectation that the new contract will be in place in October
- HAPTC were asking for the nominations to the HAPTC Executive Committee (Deadline for nominations Friday 2nd June)
- The Department for Communities and Local Government had a consultation called 'Running Free' to preserve the free use of public parks. Some Councils are charging organised groups of fitness runners which can be groups as large as 300 to cover additional repair and maintenance costs. Consultation deadline 5th July
- The 'I Love Tring' Retail Group were hosting a talk by Bill Grimsley, author of 'Sold Out', on the future of UK Retailing at the Nora Grace Hall on Wed 7th June 6:30pm

- NALC have issued a new Legal Briefing on the reform of the Data Protection Act which comes into force on the 25th May 2018. The reforms do not change the fundamental principles but it does impose new obligations on data controllers such as the Council and provides enhanced rights for individuals
- Signpost, an organisation that provides counselling services for young people, was given a grant by the Town Council last year. They have submitted their report on how the money was spent and the outcome. A copy of the report was put at Members' places
- Chiltern Society News reported the formation of a new grouping of organisations across the Chilterns to protect the Green Belt and the AONB. Members include the Chiltern Society, the Bucks, Herts, Beds & Oxon branches of CPRE, the London Green Belt Council, and the Chilterns Conservation Board
- A copy of the latest Dacorum Environmental Forum Minutes are at Members' places. A copy of their comment on the Single Local Plan was available on the table

18742. PUBLIC PARTICIPATION

Standing Orders were suspended at 8:20pm by resolution to allow members of the public present to speak.

18 residents expressed their opposition to planning application 4/00784/17/FUL on the following grounds:

- The land, albeit in private ownership, was designated open space and it should be preserved especially as there was a deficit of open land within Tring
- The scale of the proposed dwellings were out of keeping with the surrounding properties
- The development would spoil the views from the open space and into the area from other prominent parts of the Town and its surrounds
- The paths (not designated public footpaths) across the land, where the proposed development would take place, had been used for twenty years
- The gates onto the development shown in the artist's impression were too far forward and would cause obstruction of neighbouring driveways whilst access was gained

The developer (4/00784/17/FUL) responded to the above:

- The proposal gave long run security to the open space by 'sacrificing' just 20% of the land
- This will resolve the situation with split ownership of the total area so that the area as a whole can be managed properly
- The comment about gates would be taken on board
