**20082. ELECTION OF MAYOR**

It was **PROPOSED** by Cllr Townsend and **SECONDED** by Cllr McDowell that Cllr Ransley be elected Town Mayor for the ensuing year. There being no further nominations, it was unanimously **RESOLVED** that Councillor Ransley be elected Town Mayor to hold office until her successor became entitled to act as Town Mayor at the next Annual Meeting of the Council.

Cllr Ransley gave her consent to continuing in the post for another year and will sign the Declaration of Acceptance of Office in due course.

**20083. APPOINTMENT OF DEPUTY MAYOR**

Cllr Ransley opened the item to appoint a Deputy Mayor for the Council Year May 2020 to May 2021.

It was **PROPOSED** by Cllr Ransley and **SECONDED** by Cllr Patterson that Councillor Townsend be appointed Deputy Mayor for the ensuing year. There being no further nominations, it was unanimously **RESOLVED** that Councillor Townsend be re-appointed Deputy Town Mayor to hold office until the next Annual Meeting of the Council.

**20084. TO RECEIVE APOLOGIES FOR ABSENCE**

Apologies were received from Cllr J. Bowden (illness), Cllr Hearn (unforeseen circumstances) and Cllr Piper (transport delays)

**RESOLVED:** To accept the apologies for the reasons given.

**20085. TO MAKE DECLARATIONS OF INTEREST**

Cllr McDowell explained that he would not take part in item as a member of Dacorum Borough Council's Development Management Committee.

**20087. APPOINTMENT OF COMMITTEES**

**RESOLVED:** That the Town Council meets the specified eligibility criteria and as such can use the General Power of Competence granted by the Localism Act 2011 until the day of the next relevant Annual Council meeting

**20094. PUBLIC PARTICIPATION:**

Comments received with regard to planning applications were distributed to all Councillors prior to Planning Working Party's consideration of its recommendations.

**20095. PLANNING APPLICATION:**

The Council considered planning applications that had been referred by Dacorum Borough Council for observation of this authority. It was decided to request the Local Planning Authority to take the following comments into consideration when determining the under-mentioned applications.

**PLAN REF. NO.**

20/01002/FHA Two storey extension to residential dwelling. Extension to front side and rear and storage shed to front of property at 8 Meadow Close Tring Hertfordshire HP23 5BT for Mr and Mrs Russell

The Council **recommended no objection**, but with a comment that the proposed storage was considered unfavourably because of its prominent position in front of the building line.

- 20/00985/LDE Installation of a Biomass boiler and flue at Springwell Veterinary Dunsley Orchard London Road Tring Hertfordshire HP23 6HA for Mr Patrick Dale  
The Council **recommended no objection** to this application.
- 20/00136/FUL Demolition of barn, indoor school and hay barn and the construction of 6 dwellings at Pendley Farm for Mr Christopher Higenbottam  
The Council **recommended no objection** with a comment highlighting the high water table in the area and that the area was prone to flooding. Close scrutiny of the proposed drainage scheme was required to ensure it is adequate.
- 20/00979/FUL Construction of new dwelling connected to existing semi-detached properties. External refurbishment of existing two properties (renewal of application 4/01574/17/FUL) at 3 Grove Farm Cottage Marshcroft Lane Tring Hertfordshire HP23 5PP for the Regis Group  
The Council **recommended no objection** to this application.
- 20/01109/FUL Construction of new dwelling at Longfield, Aylesbury Road, Tring HP23 4DH for Mr Alastair Ames  
The Council **recommended no objection** to this application. Cllr Townsend requested that his objection was minuted.
- 20/01128/TCA T1 Willow: reduce crown by approx 40% in height and reshape to clear the property and allow light into the rear garden at 88 Western Road, Tring HP23 4BJ for Mr John Jones  
The Council **recommended no objection** to this application.
- 20/01127/TPO T1+T2 Sycamore – reduce height by approx. 2m and lateral spread by up to 4m at Dundale House, 1 Eggleton Drive, Tring HP23 5AJ for Mr John Jones  
The Council **recommended no objection** to this application.
- 20/01083/FUL Agricultural storage building at land adjacent to Abbeydawn Kennels Cholesbury Road, Tring HP23 6JQ for Mr Gordon Elliott  
The Council **recommended no objection** to this application.
