THE HERTFORDSHIRE (TEMPORARY CLOSING AND TEMPORARY WAITING RESTRICTIONS IN B486 BROOK STREET, TRING AND B4505 CHESHAM ROAD, HEMEL HEMPSTEAD) ORDER 2023

NOTICE is given that Hertfordshire County Council intends to make an Order under Section 14(1) of the Road Traffic Regulation Act 1984, to prohibit all vehicular traffic from using the following lengths of roads ("the Roads"), except for access and to prohibit all vehicles from waiting at any time on both sides of these lengths of Roads whilst works are in progress:-

1. that length of B486 Brook Street, Tring from its junction with B4635 London Road north westwards and north eastwards to its junction with Silk Mill Way, a distance of approximately 877m.

An alternative route will be via B4635 (High Street/Western Road/Aylesbury Road), B488 Icknield Way and B486 (Wingrave Road/New Mill Terrace/Wingrave Road).

2. that length of B4505 Chesham Road, Hemel Hempstead from its junction with B4505 Hempstead Road south westwards to its junction with Molyneux Avenue, a distance of approximately 608m.

An alternative route will be via B4505 (Chesham Road/Hempstead Road/Box Lane), A4251 (London Road/High Street), A416 (Kings Road/Kingshill Way/Chesham Road/Ashley Green Road/Nashleigh Hill/Berkhampstead Road/Broad Street) and B4505 (Eskdale Avenue/Lye Green Road/Orchard Leigh/Rushmere Lane/Chesham Road).

The Order is needed because works are proposed to be executed on or near the Roads.

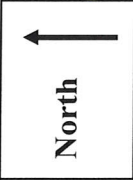
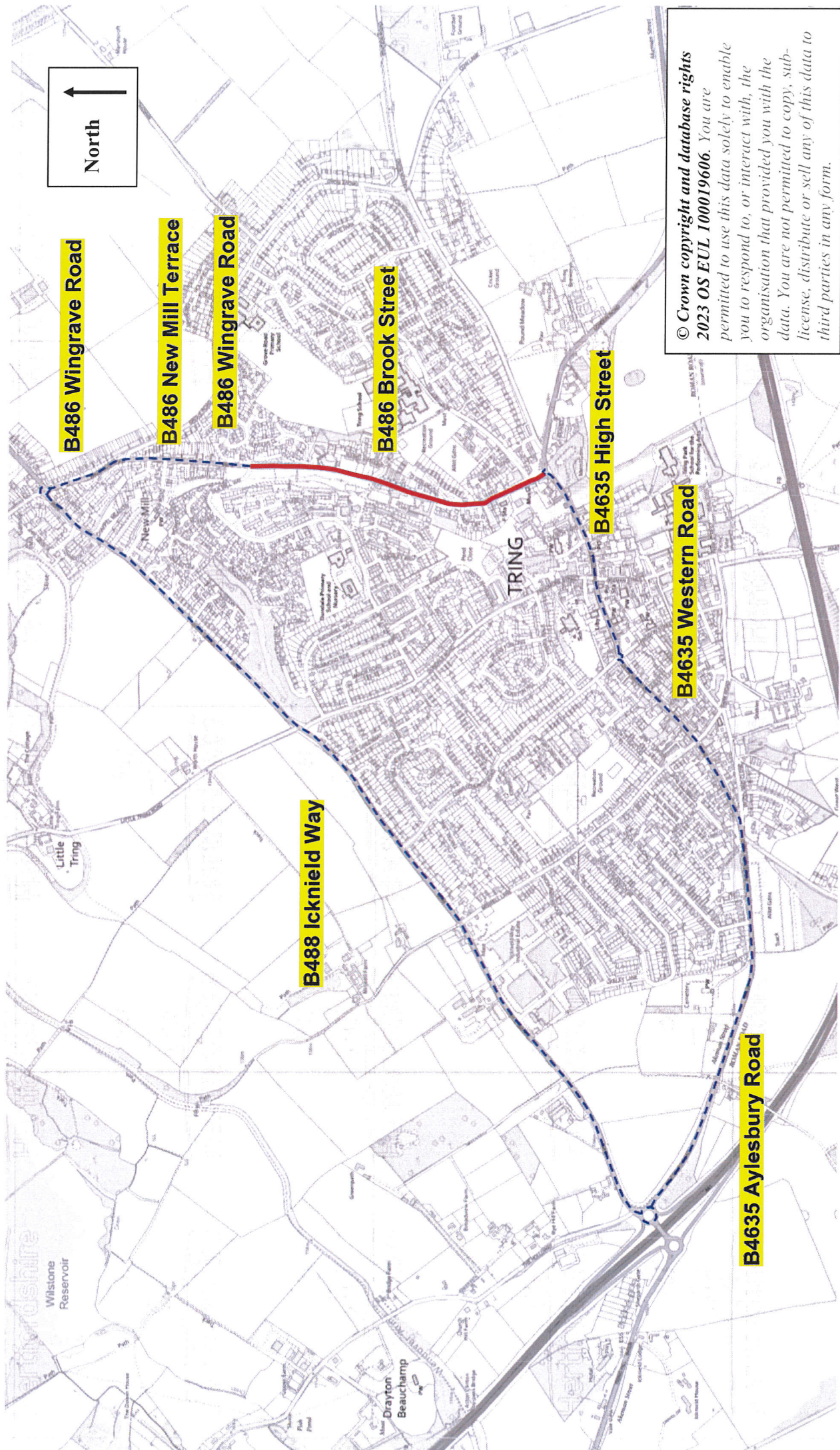
If the Order is made, it shall come into force on 27 June 2023 for a period of up to 18 months. However, the restrictions specified shall only take effect at the times indicated by signs on or near the Roads.

A copy of the proposed Order may be inspected free of charge at County Hall, Hertford between the hours of 9.00am and 5.00pm (excluding weekends, bank and public holidays).

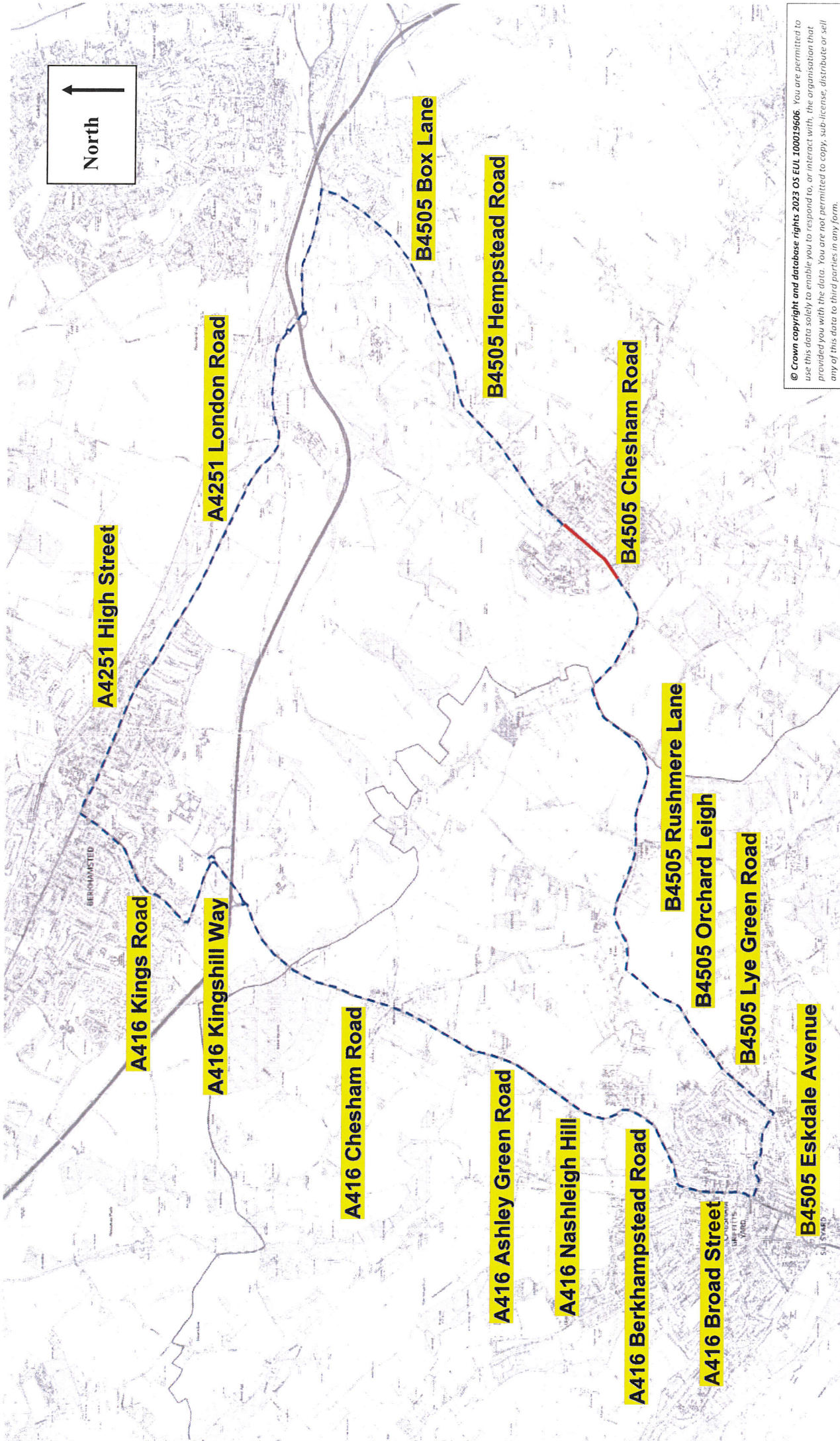
