21423. CHAIRMAN'S COMMUNICATIONS

- The various parties' closing statements have been circulated, for information, in relation to the appeal application that was heard for the proposed development at the Land East of Tring.
- She had attended the Town & Parish Council session with DBC on planning matters on 5th May 2023. They had confirmed that they are taking on a new enforcement employee who starts in June and bringing in a temporary officer to target the high priority cases and backlog. This is to address the currently unmanageable backlog and a large amount of appeals.

They will shortly be sharing a new frequently asked questions form on enforcement guidance and had provided a copy of the DBC Local enforcement plan which has now been included in the new councillors welcome pack. These documents should help the members make informed decisions as to where to signpost residents to so that matters go to the correct department.

The Clerk had enquired, as requested by the Council following a recent planning application, if the Town Council should be commenting on Lawful Development certificate applications. She was told that the Town Council's objections wouldn't ordinarily hold any weight but they were useful to provide local knowledge. For example the application may be dependent upon the applicant having lived in the property for a certain period and the Town Council may know if that is true or not.

They had hoped to give an update on the Land East of Tring appeal but they ran out of time so said that they would make it a specific topic at the next meeting. The Clerk reported that a letter had been received from the applicant of a
planning application that had been considered at the annual council
meeting in respect of a request to use land at West Leith for dog walking.
This correspondence had been circulated and the clerk had responded
notifying the resident that the Town Council's decision had already been
made.
